



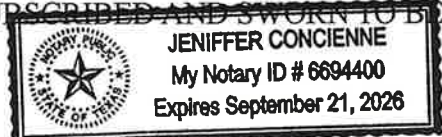

Before me, the undersigned authority, personally appeared Dennis B. Daniel, who upon oath deposed and stated:


1. My name is Dennis B. Daniel, and I am currently the President of the Board of Directors of Reunion Ranch Water Control and Improvement District (the "District").
2. I have personal knowledge of the facts set forth below, which are all true and correct, am over 18 years of age, and am competent to make this Affidavit.
3. I am filing this Affidavit with the District to comply with Chapter 171, Texas Local Government Code, and to state the nature and extent of a substantial interest in a business entity doing business with the District. That business entity is the Lower Colorado River Authority (the "LCRA"), which supplies raw water to the District.
4. I was previously employed by and currently receive a pension from the LCRA which exceeds ten percent (10%) of my gross income for the previous year. My pension from the LCRA constitutes a substantial interest in the LCRA as described in Section 171.002, Texas Local Government Code.
5. In conformance with the requirements of Chapter 171, Texas Local Government Code, I shall abstain from any discussion, vote, or decision on any matter involving the District and LCRA that will have a special economic effect on the LCRA that is distinguishable from the effect on the public, including any budget items specifically dedicated by the District to a contract with the LCRA, so long as I continue to have a substantial interest in the LCRA.
